

Dear Parishioners,

On July 1, we celebrated our second year as a parish. While COVID-19 has prevented us from resuming all of our pre-pandemic activities, we have been open and ministering safely to those in Somerville and beyond. Thanks to your generosity, as well as our investments and lease income, we were able to end the year in a stable position. The forgiveness of our PPP loan for the parish has helped mitigate our losses in income.

We have invested heavily in our campuses this past year; of the \$328,000 Capital Improvements: \$63,000 deposit for St. Joseph Organ Repair; \$182,610 for the Retaining Wall at St. Ann (final payment is in FY22); \$61,260 for the rebuilding of St. Catherine Garage, Masonry repairs and new shutters for St. Catherine Rectory. We have eleven buildings, and the majority are over 100 years old. Maintenance is constant; we continue to do our best to protect the patrimony of our parish.

We have permanently closed our bingos. We thank all those who gave of their time for decades to keep them running and to all those who came and enjoyed the fun.

St. Theresa School, on the other hand, had a very difficult year. COVID-19 resulted in a reduction of 40 children from the year prior; this was a large reduction in tuition. We were able to have the \$162,500 PPP loan forgiven and the state granted us \$120,000 in reimbursable COVID expenses. However, the loss of tuition caused us to end with a \$200,000 deficit. We have enrolled a few more children for the 2021-22 year and the school board is aware of the financial situation and is drafting strategies to get us back into the black. Let us pray to the Little Flower for the success of our school.

The figures for the last year and a budget are shown; the budget is conservative, given the uncertainties, but it looks like we will end the year in a good position. With your help and generosity, Sts. Louis and Zelig Parish is poised to continue caring for her parishioners and worshipping God for years to come.
